

## **Mobile Rock Wall Policies**

### **Reservation Policies**

1. Reservations can be made by calling (951) 827-4473.
2. A 50% deposit is due at time of reservation. The balance is due the day of the program.
3. In the event the client cancels less than seven working days prior to the date of the event the client will forfeit the entire booking fee.
4. If UCR Recreation/UCR Team Excursions cancels the program for any reason including weather, staff illness, road conditions or emergency the client will receive a full refund. If UCR Recreation/UCR Team Excursions does not show the client will not receive any kind of compensations for losses.

### **What Outdoor Excursions Provides**

1. 2-3 trained staff to provide instruction and supervision.
2. The climbing wall and all necessary equipment.
3. Setup and take down of the Mobile Rock Wall.
4. Required waiver and release forms that need to be signed by all participants (minors need a parent/legal guardian signature).

### **What the Client Provides**

1. Level site (less than 3% slope) large enough for the climbing wall footprint (20 long by 9 feet wide) and about an 8 foot space in front of the wall in all directions.
2. Area to sign release forms and to put on harnesses.
3. Access to the event area for set up 1 hour prior to start time and the ability to take down and leave the site 1 hour after the program time.
4. Electrical hook up for 4 500-watt lights for night time programs.

### **Eligibility**

1. A completed waiver is required for every participant before they are allowed to climb. A waiver is valid only for the day of the program only.
2. Participants under the age of 18 must also have a parent or legal guardian sign the waiver.
3. Participants that have already completed a waiver for the mobile climbing wall or any other UCR Recreation event will need to complete a new waiver before climbing.
4. All climbers must fit into the manufactures harnesses according to their specifications. Those that can not fit into a harness will not be able to climb.
5. All climbers must have closed toed shoes.
6. All climbers must weigh between 45 – 250 lbs.

## Site Requirements

1. The climbing wall is transported in the down position by a standard size pickup, suburban or van and can be located anywhere the vehicle can be driven with 10 feet of vertical clearance.
2. The rock wall site needs to be level (less than a 3% slope).
3. The trailer occupies a foot print of 20 feet by 8 feet with the wall in the upright position.
5. The upright wall needs 30 feet of vertical clearance.
6. The area in front of the wall should have at least 8 feet of clearance for the climbing zone.
4. The Rock Wall is 25 feet tall with 5 routes and a total climbable surface of 524 sq. feet. The wall weighs about 5,000lbs.
7. The surface where the wall will sit and the access to the site must be firm and must have at least 2,000lb./sq.ft. load bearing strength.
8. The site should have no overhead obstructions and can not be set up if wind gust are over 30MPH, or outside if lightning is expected.
